BY DOCTOR KARINA SALUO: The semen will be collected and professionally transported to the buyers address above or to the designated address of your Veterinary for artificial insemination by that vet German shepherd stud international does not perform artificial insemination.

Compensation. Bitch Owner agrees to pay PP USA LLC a [non-refundable] semen fee of \$2000. All payments due under this Agreement shall be made in US Dollars via payments through bank wire, check, or ACH transfer.

The parties agree that any Artificial Insemination or Transcervical Insemination must be performed by a licensed veterinarian or breeder which will be the responsibility and the expense of the bitch owner

Semen Collections. Stud Dog Owner agrees to provide one semen collections and shipment for non-local breedings. German Shepherd Stud International shall be responsible for all expenses associated with

collecting and shipping such semen which will be collected analyzed certified good & safely dispatched to the bitch owner by Dr. Karina Salvo

Vaccinations and Exams. Bitch Owner agrees to accept full responsibility to ensure that all offspring resulting from the Breeding be treated for parasites and receive vaccines when indicated.

Bitch Owner Obligations. Bitch Owner represents, warrants and agrees as follows:

- a. Bitch. The Bitch is healthy, of sound and stable temperament, is of breeding quality, disease and parasite-free.
- b. Notification. To notify Stud Dog Owner, in writing (by email or text), of the birth and number of puppies within a week of the Breeding.

Stud Dog Owner Obligations. Stud Dog Owner represents, warrants and agrees as follows:

- a. Stud Dog. The Stud Dog is healthy, of sound and stable temperament, is of breeding quality, is parasite and disease-free
- b. Stud Dog Documentation. To provide Bitch Owner a 5 generation pedigree of the documentation provided by Dr. Karina Salva showing that the Stud Dog is in good physical condition with a negative Brucellosis test documentation showing the Stud Dog is in good health, current on all vaccinations; which will accompany the transported semen and which documentation will be maintained by Dr. Karina Salva.
- c. Litter Registration. To sign promptly and return any litter registration to Bitch Owner.

Confidentiality of Disputes. Bitch Owner and GSSI agree, that in the event of a dispute between them, neither will publish or communicate the existence or content of such dispute in any media or forum, including social media, provided that this provision shall not prevent either party from bringing legal action or engaging in confidential mediation.

Agreement to Mediate. If a dispute arises out of or relates to this Agreement, or the alleged breach thereof, and if the dispute is not settled through negotiation, the parties agree first to try in good faith to settle the dispute by mediation before resorting to arbitration, litigation, or some other dispute resolution procedure. The process shall be confidential based on terms acceptable to the mediator and/or mediation service provider.

Governing Law. This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by and construed in accordance with the laws of the State of Florida without regard to the conflicts of laws provisions thereof. Miscellaneous. This Agreement constitutes the entire agreement between the parties regarding the subject matter herein and supersedes all prior or contemporaneous agreements, negotiations, discussions and understandings, written or oral, between the parties with respect to such subject matter. Neither party may assign, transfer, or subcontract any obligations (or rights) under this Agreement without the prior written consent of the other party. No changes, modifications or waivers to this Agreement will be effective unless in writing and signed by both parties. In the event that any provision of this Agreement is determined to be illegal or unenforceable, that provision will be limited or eliminated to the minimum extent necessary so that this Agreement shall otherwise remain in full force and effect and enforceable. This Agreement may be executed in any number of counterparts and such counterparts together shall constitute the same instrument. This Agreement may be executed by electronic signature, which shall be considered as an original signature for all purposes and shall have the same force and effect as an original signature.
